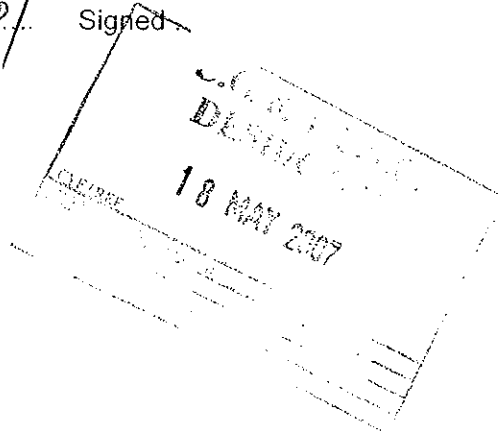
\*2 upgrading/downgrading to a footpath/bridleway/restricted byway/byway open to all traffic the route known as to and running from and shown on the attached map.

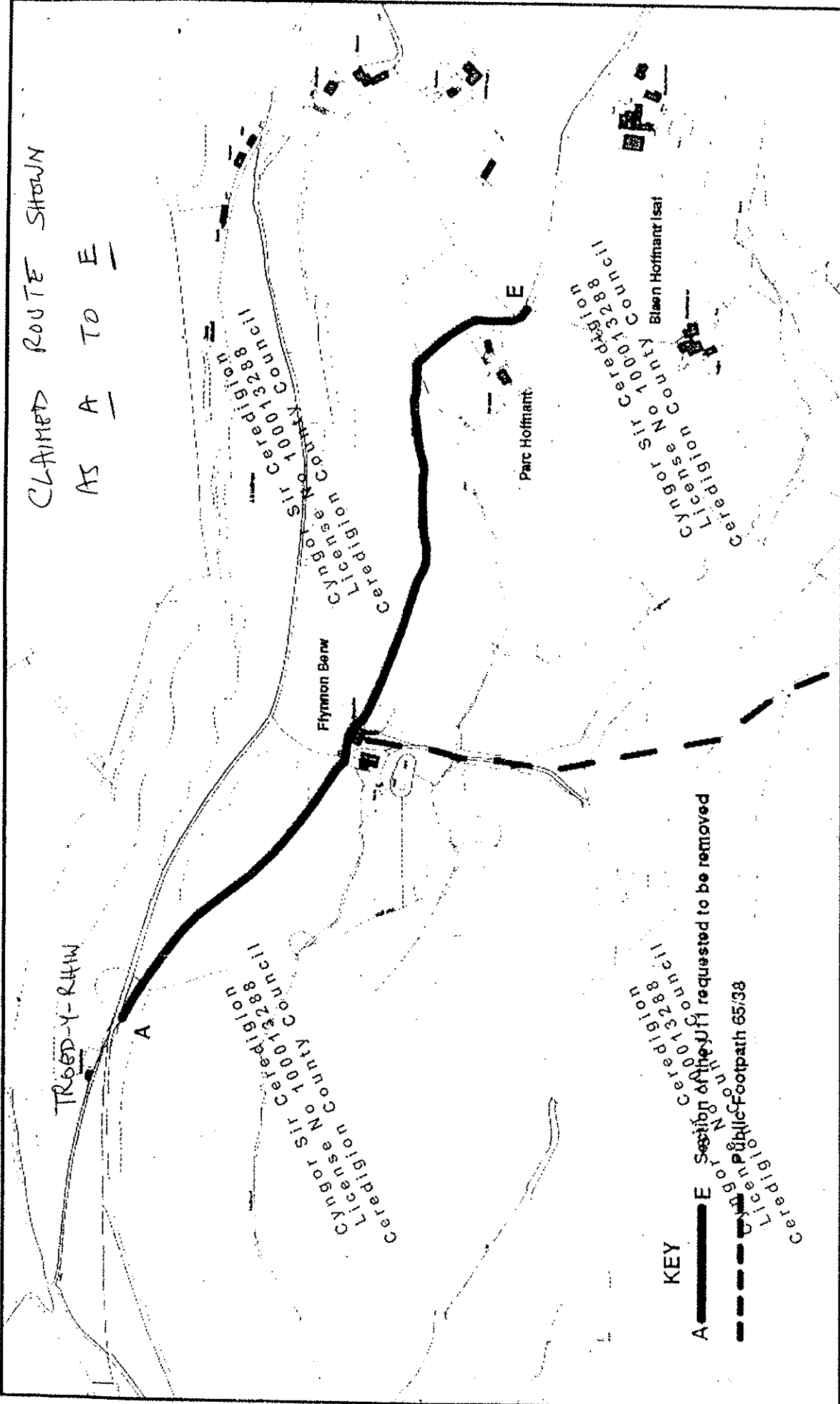
