## **Annex 1 - Mandatory conditions**

### **Mandatory conditions where licence authorises supply of alcohol**

- (1) No supply of alcohol may be made under the premises licence—
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### **Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:**

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
  - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
  - (b) in respect of premises in relation to—
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
  - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

## **The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010**

### **With effect from 6<sup>th</sup> April 2010**

1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children –

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act );

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

(d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

(i) the outcome of a race, competition or other event or process, or

(ii) the likelihood of anything occurring or not occurring;

(e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

**With effect from 1<sup>st</sup> October 2010**

4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

5. The responsible person shall ensure that –

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –

(i) beer or cider: ½ pint

(ii) gin, rum, vodka or whisky: 25ml or 35ml; and

(iii) still wine in a glass: 125ml; and

(b) customers are made aware of the availability of these measures.

## **The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2014**

**With effect from 28<sup>th</sup> May 2014**

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
2. For the purposes of the condition set out in paragraph 1-
  - (a) “duty” is to be construed in accordance with the Alcoholic Liquor Duties Act 1976(6);
  - (b) “permitted price” is the price found by applying the formula –  
$$P = D + (D \times V)$$
where –
    - (i) P is the permitted price
    - (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
    - (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol
  - (c) “relevant person” means, in relation to premises in respect of which there is in force a premises licence –
    - (i) The holder of the premises licence,
    - (ii) The designated premises supervisor (if any) in respect of such a licence, or
    - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
  - (d) “relevant person” means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
  - (e) “valued added tax” means value added tax charged in accordance with the Value Added Tax Act 1997(7)

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
4. (1) Sub-paragraph (2) applies where the permitted price by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.  
  
(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.



## **Annex 2 - Conditions consistent with the operating Schedule**

### **a) General**

1. Oernant Farm is located between Cardigan and Penparc adjacent to the A487. The proposed event will use two fields detailed in the map and plans accompanying this application. One field will be used exclusively for car parking and camper van camping site, the other will be the festival site with camping and all facilities for licensed entertainments and activities as described. The festival site within this field will be have temporary Heras-style fencing and access will be controlled by SIA licensed festival security staff supplemented by volunteer marshalls and stewards. Within the festival site there will be a Four licensed tents

E – Main tent

G – Dance tent

H – Outside stage

I – Acoustic tent

Refreshments, including alcohol, will be available in bar areas and from stalls and cafes in the areas indicated on the plan.

Crug Mawr is intended to be an annual Music and Arts Festival for people in the Cardigan area and beyond. It will contain a family-friendly mix of regulated entertainment for adults and accompanied children with stalls selling food and drink (see attached plan). The event will include facilities for the public to purchase alcohol for consumption on site. The festival site will be contained in a fenced off area with access controlled by SIA licensed, festival friendly door staff (male and female) supplemented by trained volunteer stewards and marshalls.

Total capacity for the event at any time will be 2000

### **b) The prevention of crime and disorder**

We will consult with and take advice from all of the licensing authorities before the event to anticipate any potential problems and put appropriate safeguards in place to address these.

### **c) Public safety**

We have completed a health and safety risk assessment. Trained first aider will be on site throughout the event and appropriate equipment will be available. Fencing will be used where required to maintain security, safety and site integrity. SIA licensed door staff will be used, supplemented by volunteer stewards and marshalls, to ensure that the site is safe and orderly. Lighting will be used to ensure that the public are able to walk around the site safely during the evening. Alcohol will be served in plastic glasses or tins – no glass.

**Door supervisor** – Security company will be Rock Security Trefawr Llanfyrnach for 2014, should the provision of Door Security in terms of companies change in future years, the applicant will inform L.A within 3 months of the date of the event of the new arrangements.

- a) Names and SIA Licence numbers will be provided to the Licensing Section two weeks before the event
- b) SIA Door Supervisors

There will be six SIA doorpersons on duty at the venue 30 minutes before the event opens to cover the 1<sup>st</sup> 500 attendees, with security increased at the rate of 1 SIA door person per 150 or part thereof

- i) Mixture of male and female door supervisors, - as offered by applicant

**Drugs** - Any person found in possession of drugs will be evicted and we will phone the Police immediately to report the crime.

**d) The prevention of public nuisance**

SIA door staff and stewards will be employed on site to keep any public nuisance under control. The event is intended to be family friendly and due consideration will be given to the possibility of noise nuisance, so the site will be frequently monitored for noise escape. Neighbours and businesses in the area will be leafleted prior to the event informing them of relevant details and giving contact information for any queries or feedback.

**e) The protection of children from harm**

We request that all persons that appear to be under the age of 21 provide identification to prove their age before alcohol is purchased. Door staff will be instructed to check I.D on entry to licensable area. There will be two different coloured wristband for over 18's and under 18's/ Bar staff will be instructed on difference in bands.

Crug Mawr Ltd event – will remove children under 10 years old from the licensable area at 12 midnight.

A notice stating "it is illegal for an under 18 year old to attempt to purchase alcohol" will be displayed at or near the entrance of venues selling age restricted products.

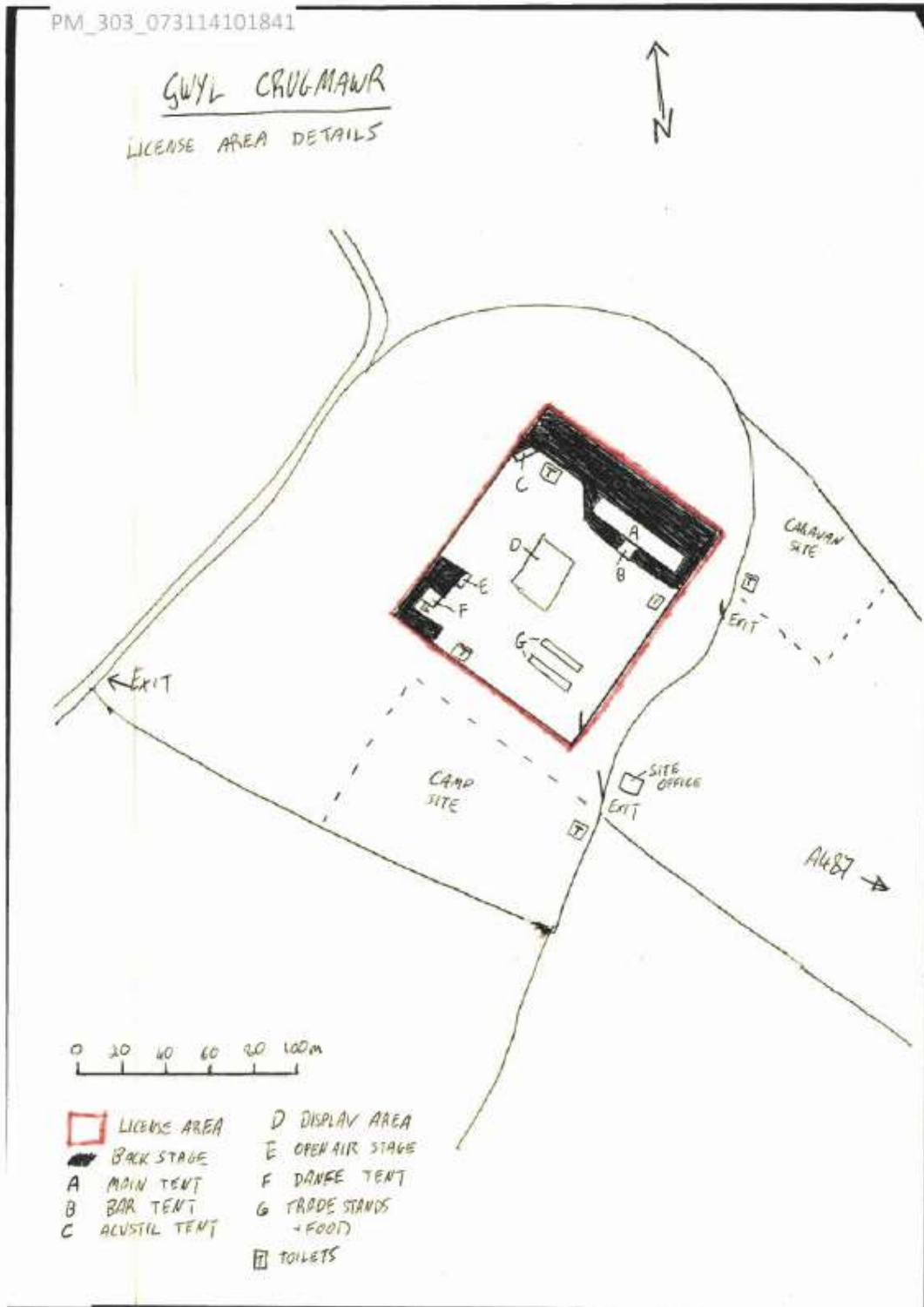

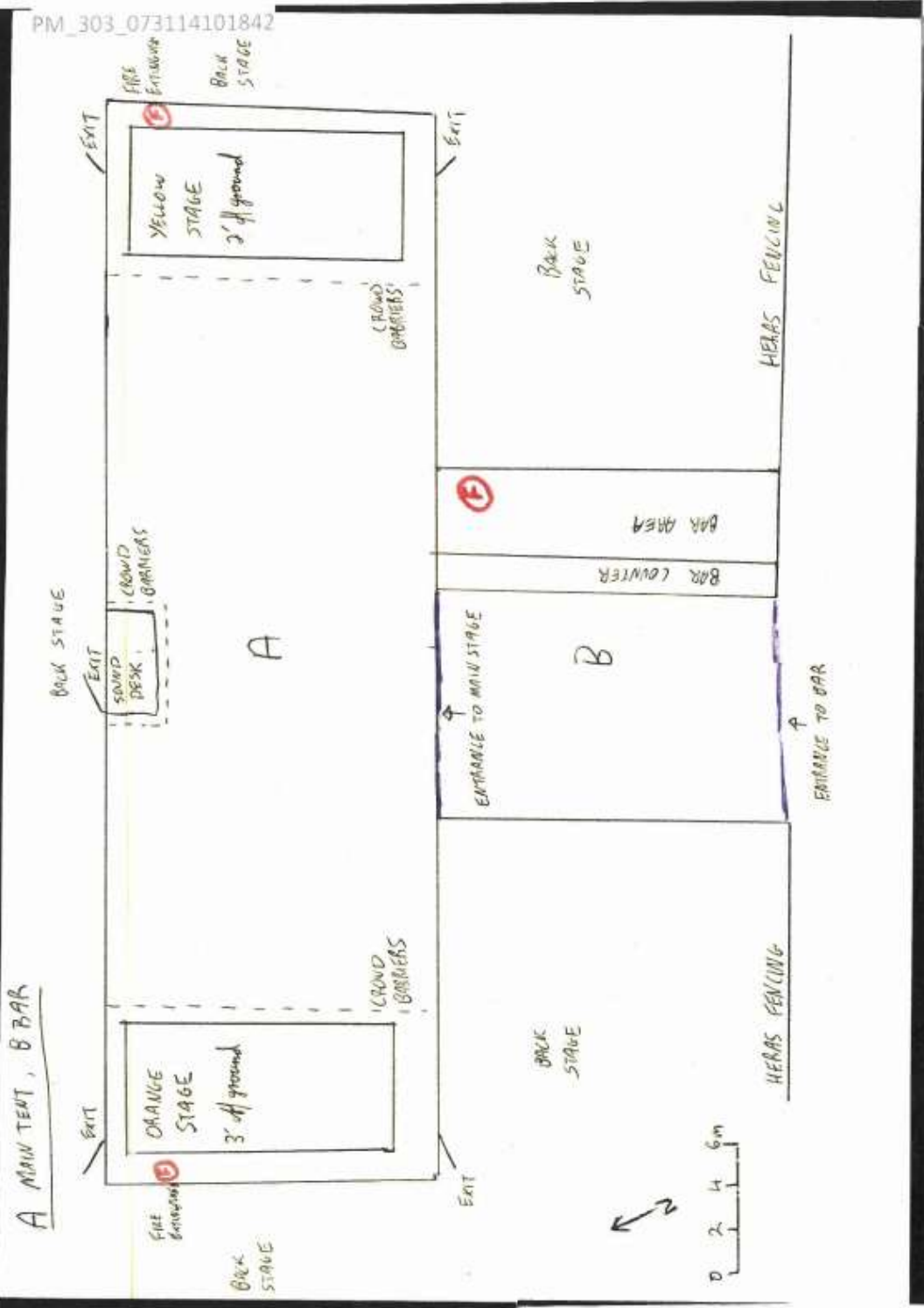

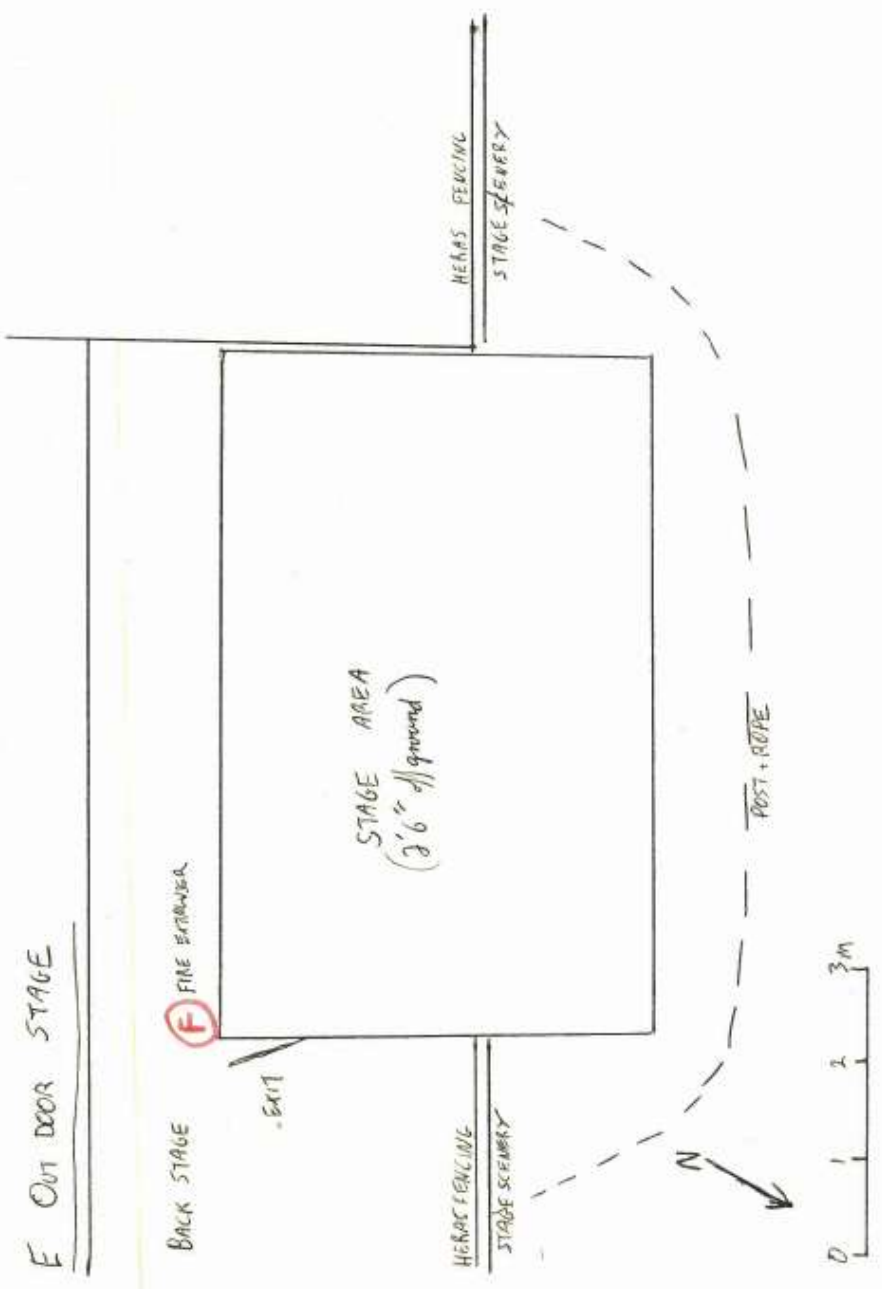
