## **Annex 1 - Mandatory conditions**

### **Mandatory conditions where licence authorises supply of alcohol**

- (1) No supply of alcohol may be made under the premises licence—
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### **Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:**

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
  - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
  - (b) in respect of premises in relation to—
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
  - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

## **Annex 2 - Conditions consistent with the operating Schedule**

### **General- all four licensing objectives**

To follow the British Beer and Pub Association code of practice regarding irresponsible drinks promotions and Portman group code on displaying and advertising alcoholic beverages

### **The prevention of crime and disorder**

- Signage will be displayed on the premises outlining the Dyfed Powys Police 'Customer Code of Contact' and the consequences of any breaches.
- CCTV is installed and all recordings are made and kept in accordance with the policy recommended by the Police
- Open containers will not be permitted to be taken out of the premises
- Anyone who appears to be under 21 yrs old will be asked for photographic proof of age

### **Public safety**

- The fire safety equipment is checked in accordance with the British Standards Institute every year and relevant certification is obtained.
- All drinking glasses are manufactured from toughened glass

### **The prevention of public nuisance**

- Noise reduction signage will be displayed on the premises reminding customers to leave the premises quietly
- At close time the management will request customers to leave quietly
- Windows and doors at the premises will be kept closed after 23:00hrs

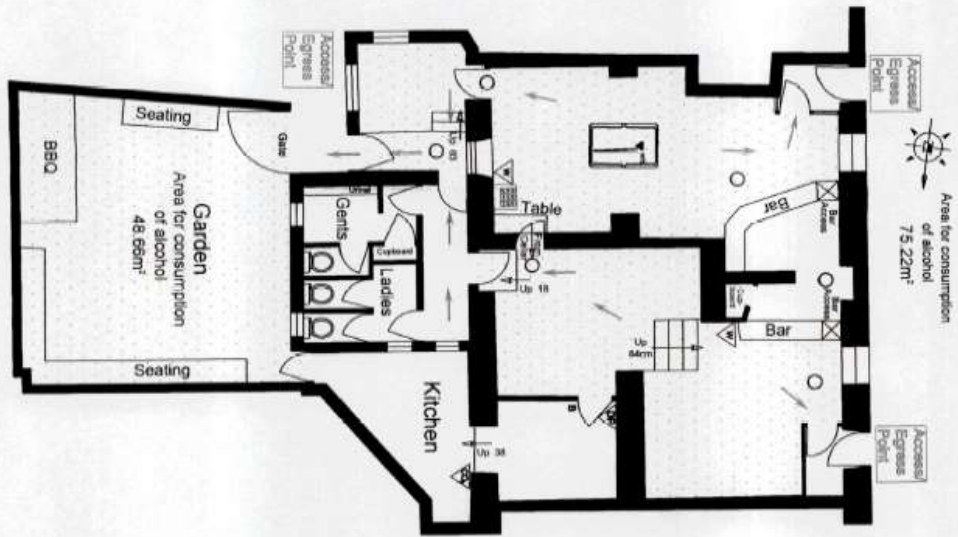
### **The protection of children from harm**

Passport, driving licence or local/nationally-recognised proof of age documents e.g. Validate UK, Portman Group Cards will be required to establish the age of any person trying to buy alcohol who appears to be under 21. Any person attempting to buy alcohol who is under 18 will be refused.
