

STATUTORY DECLARATION

Section 31(6) of the Highways Act 1980.

I Edward David Williams for and on behalf of AMLWG Ltd. DO SOLEMNLY AND SINCERELY DECLARE as follows

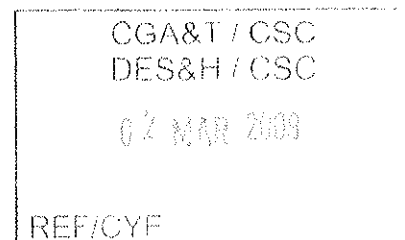
1. I am and have been since 11th. February 1988 as Director of Amlwg Ltd. the owner of the land known as Pantamlwg, Trefenter, Aberystwyth, Ceredigion more particularly delineated on the plan accompanying this declaration and thereon edged in Black.
2. On the 17th February 2009 I deposited with Ceredigion County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by Black edging which stated that :-
3. The ways coloured Red on the said plan and on the plan accompanying this declaration had been dedicated as Footpaths.
4. The ways coloured Orange on the said plan and on the plan accompanying this declaration had been dedicated as Restricted Byways.
5. The ways coloured Green on the said plan had been dedicated as Bridleways.
6. No other ways had been dedicated as highways over my property.
7. No additional ways have been dedicated over the land edged in Black on the plan accompanying this declaration since the statement dated 17th February 2009 referred to in 2. above, and at the present time I have no intention of dedicating any more public rights of way over my property.

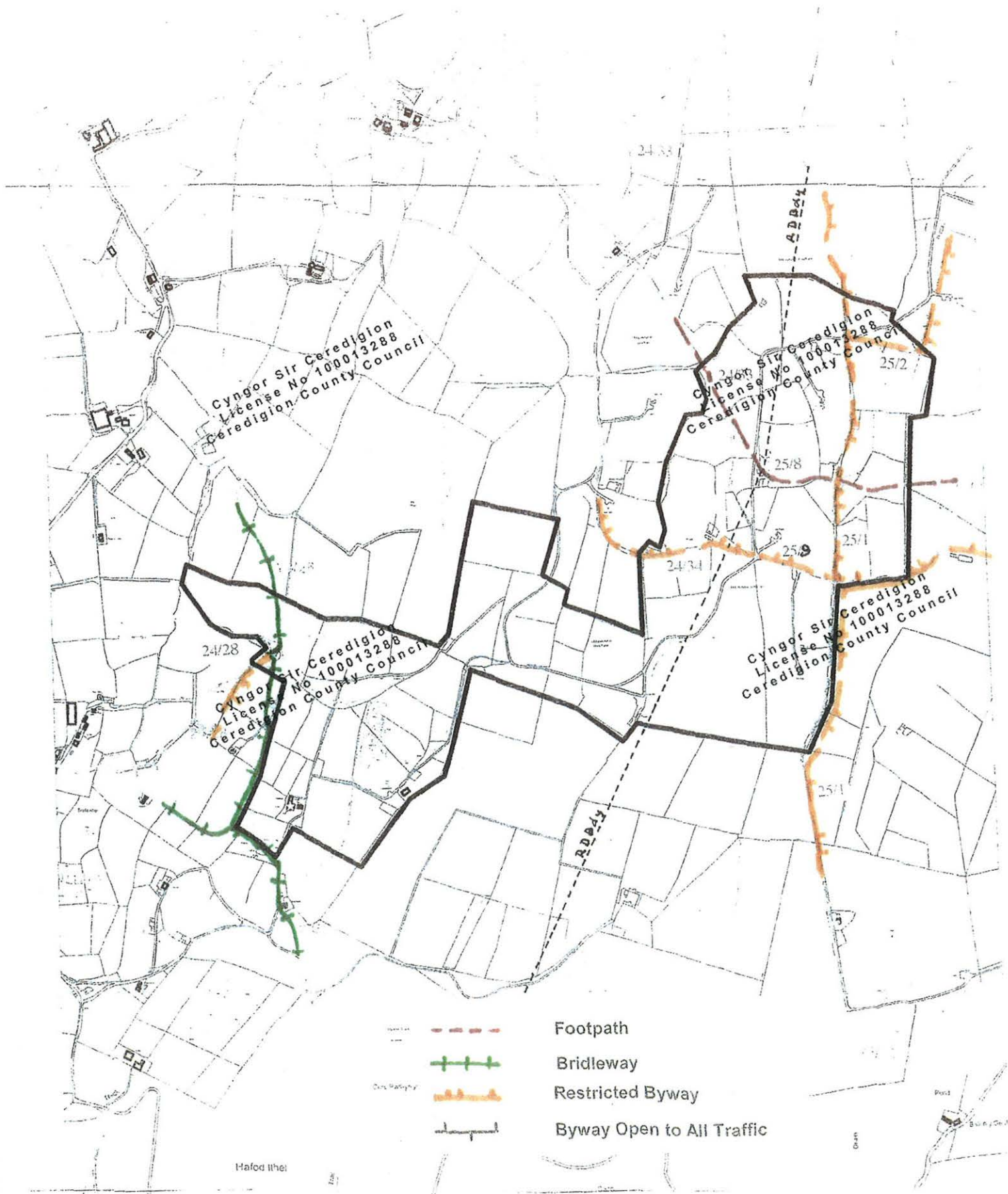

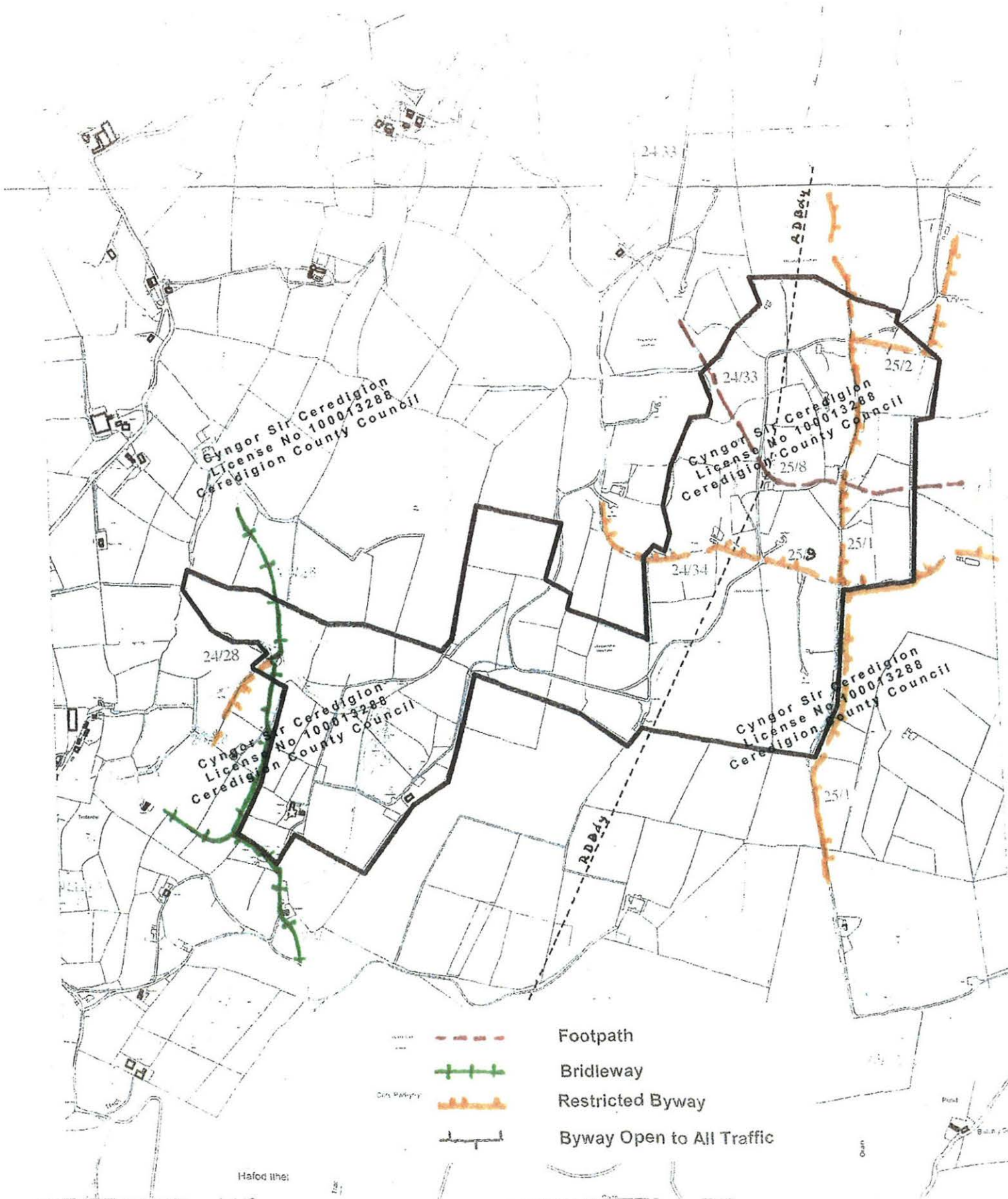
