Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

- a. General-all licensing objectives:- In general terms the management committee will try and ensure that the premises are only used by responsible people. Agreement to have proper supervision of all events will be a requirement of hiring the premises, as will a plan being in place for emergency situations.**
- b. Prevention of Crime and Disorder:- Any activity which is seen to be promoting crime and disorder will be stopped and the hirers of the hall will be asked to leave.**
- c. Public Safety:- The building is inspected regularly. Statutory inspections are carried out with any defects being rectified immediately. All users are instructed in the procedures should fire break out, fire extinguishers are provided and serviced regularly by specialists. All fire exits are kept clear and push bolts etc in good working order. Signs are in place regarding fire procedures.**
- d. Prevention of Public Nuisance:- All users are asked to ensure that activities do not spill out into the street and to make public announcement regarding leaving the premises orderly and quietly.**
- e. Protection of Children from Harm:- All Management are alert to possible hazards whether they be physical-trip/falling hazards etc or the possibility of abuse type hazards. We ask all hirers to be aware also.**
