

PUBLIC NOTICE

CEREDIGION COUNTY COUNCIL TOWN & POLICE CLAUSES ACT 1847 (SECTION 21) ABER BEER FEST 2025

NOTICE is hereby given that the Ceredigion County Council has made the following Order under Section 21 of the Town Police Clauses Act 1847 for the Prevention of Obstruction etc.

WHEREAS during certain hours on Thursday 28th August, Friday 29th August and Saturday 30th August 2025, between the hours of 11:00 – 21:00 hours due to Aber Beer Fest 2024 taking place, that sections of the roads known as Cambrian Place, Aberystwyth in the county of Ceredigion, will be thronged and liable to be obstructed. Ceredigion County Council pursuant to the powers conferred by Section 21 of the Town Police Clauses Act 1847 DO HEREBY ORDER AND DIRECT that for the purpose of preventing obstruction in the said roads on the said day the following regulations shall be observed:-

1. Subject to those provisions contained in articles 3 and 4, those sections of road known as Cambrian Place, Aberystwyth in the county of Ceredigion shall be closed to all vehicular traffic including pedal cycles between the hours of 11:00 – 21:00 on Thursday 28th August, Friday 29th August and Saturday 30th August 2025.
2. Subject to those provisions contained in articles 3 and 4, those sections of road known as Union Street, Aberystwyth in the county of Ceredigion shall be incidentally closed to all vehicular traffic including pedal cycles at their junctions with sections of road mentioned in article 1. between the hours of 11:00 – 21:00 on Thursday 28th August, Friday 29th August and Saturday 30th August 2025.
3. The provisions of article 1 and 2 shall apply only during such times and to such extent as the application of the restrictions referred to therein are indicated by traffic signs or designated stewards.
4. Nothing in article 1 and 2 of this order shall apply to any vehicle being used by the emergency services, vehicles being used in connection with the events giving rise to this order, or anything done with the permission or under the direction of a police officer.
5. The alternative route is as follows: South-west bound traffic from Terrace Road, travel on Terrace Road to its junction with North Parade. Continue on North Parade to its junction with Thespian Street. Turn right onto Thespian Street and continue onto Alexandra Road to the first roundabout. Take the 2nd exit at the roundabout continuing on Alexandra Road to the second roundabout. Take the 2nd exit at the roundabout into Mill Street. Travel on Mill Street to its junction with Bridge Street. Turn right into Bridge Street and continue into Great Darkgate Street. Continue on Great Darkgate Street to its junction with Chalybeate Street. Turn right into Chalybeate Street and continue to a point south-west of the closure.

Pedestrian access will be maintained at all times.

The penalty for infringement of the said Regulations is a fine not exceeding one thousand pounds.
