Avoid Financial Scams with FCA Firm Checker

Scams involving investments, pensions and financial services are on the rise, with around 800,000 people affected in a single year. To help people stay safe, the Financial Conduct Authority (FCA) has launched Firm Checker.

Firm Checker is a simple online tool that lets you check whether a financial services firm is authorised and has permission to offer the service being advertised. This is important, as scammers often pretend to be genuine companies and may contact people via phone calls, texts, WhatsApp or social media.

Before making any financial decision or sharing personal information, take a moment to use FCA Firm Checker and protect yourself from fraud.

Draft dementia strategy for Wales 2026 to 2036

The Welsh Government is consulting on a new Dementia Strategy for Wales, which will replace the previous Dementia Action Plan (2018) and the follow-up document from 2021, updated after the challenges of the COVID-19 pandemic.

The plan will be co-produced, meaning people with lived experience, partners, and stakeholders will be involved throughout. This consultation gives you an early opportunity to share your views, which will help shape the final strategy in 2026.

The closing date for responses is 3 April 2026.
