## **Annex 2 - Conditions consistent with the Club Operating Schedule**

**Premises is subject to embedded conditions converted under Section 40, Licensing Act 1964.**

### **PROMOTION OF LICENSING OBJECTIVES:**

- **General – All four licensing objectives:** The following objectives have always been of great concern to the management of the railway club and will remain.
- **Prevention of Crime and Disorder:** This committee is united against crime and disorder, and do not allow the premises to be used unlawfully.
- **Public Safety:** Safety requirements are strictly adhered to and all necessary checks are carried out periodically.
- **Prevention of Public Nuisance:** The club is situated on its own land with no through access, away from residential areas with no noise sensitive premises near.
- **Protection of Children from Harm:** The Committee have a strict rule that persons under the age of 18 will not be served with alcohol or play the gaming machine. All children must be accompanied by their parents who are full club members.
