## **Annex 1 - Mandatory conditions**

### **Mandatory conditions where licence authorises supply of alcohol**

- (1) No supply of alcohol may be made under the premises licence-
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### **Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:**

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
  - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
  - (b) in respect of premises in relation to—
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
  - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

## Annex 2 - Conditions consistent with the operating Schedule

### PROMOTION of LICENSING OBJECTIVES:

a) General - all four licensing objectives (b,c,d,e) (please read guidance note 9)

ALL REQUESTS FROM INDIVIDUALS OR ORGANISATIONS TO HIRE THE HALL ARE CONSIDERED CAREFULLY AND THE HIRERS' RESPONSIBILITIES ARE EXPLAINED TO THEM. NO ALCOHOL IS PROVIDED FOR SALE UNLESS A TEMPORARY EVENTS NOTICE HAS BEEN RECEIVED

b) The prevention of crime and disorder

HIRERS HAVE A RESPONSIBILITY TO PREVENT DRUNKEN VIOLENT QUARRELSOME OR DISORDERLY BEHAVIOUR ON THE PREMISES. SHOULD THIS EVER OCCUR SUCH PERSONS WOULD BE ASKED TO LEAVE. THERE IS A BURGLAR ALARM SYSTEM.

c) Public safety

ALL ELECTRICAL EQUIPMENT IS CHECKED ON A REGULAR BASIS. FIRE EXTINGUISHERS FIRE EXITS AND SIGNS, EMERGENCY LIGHTING AND A FIRST AID KIT ARE ALL PROVIDED. PUBLIC LIABILITY INSURANCE IS IN FORCE AND A COPY OF THE SCHEDULE IS DISPLAYED IN THE HALL

Fire Service Calculated Occupancy – 60 persons.

d) The prevention of public nuisance

THE HALL IS NOT LOCATED CLOSE TO RESIDENTIAL PROPERTY. DOORS AND WINDOWS IN THE HALL ARE KEPT CLOSED WHEN LIVE MUSIC IS PLAYED. SIGNS ARE IN PLACE ASKING PEOPLE TO LEAVE THE PREMISES QUIETLY AND RESPONSIBLY

e) The protection of children from harm

UNSUPERVISED CHILDREN ARE NOT PERMITTED ON THE PREMISES.  
CHILDREN PRESENT MUST BE SUPERVISED AT ALL TIMES
